



## Vendor's Contract with Allegany County Celtic Festival, Inc.

WITNESSETH, that the Vendor and the Allegany County Celtic Festival, Inc. for the considerations named agree as follows:

### ARTICLE 1 – SCOPE OF WORK

The Vendor shall receive a space at the festival from which to sell their wares. The Vendor will be responsible for keeping their own area clean and tidy, and will place all garbage and debris in trash bags that the Vendor provides. If any debris/garbage is left behind that is not bagged, the Vendor will not be permitted to return to future festivals.

### ARTICLE 2 – VENDOR FEE

The Vendor agrees to pay seventy-five dollars (\$75.00) to Allegany County Celtic Festival, Inc. and provide their own tent, tables, etc. The Vendor agrees to pay said \$75.00 by \_\_\_\_\_, which is two (2) weeks prior to the festival date.\* Checks may be made out to: Mary A. France Abraham, and mailed along with this signed contract to: 7070 Gleason Hill Rd. S. – 6, Belfast, NY 14711.

\* If the vendor fee is paid in full by March 17<sup>th</sup> of the festival year, the fee will be reduced to \$60.00!

**ARTICLE 3 – CANCELLATION POLICY**

The Vendor agrees to provide a notification of cancellation of **NO LESS THAN 2 WEEKS PRIOR TO THE FESTIVAL DATE OR THEY FORFEIT THEIR VENDOR'S FEE.**

**ARTICLE 4 – NUMBER OF WORKERS ALLOWED PER CONTRACT**

The Vendor agrees that any additional persons exceeding the allowed 2 in total (the vendor and their helper) will be required to pay for a festival ticket at the Main Gate.

**ARTICLE 5 – FOOD VENDORS**

The Food Vendor must have their certificate from the Health Department with them at the festival to present to the Department of Health representative. If a certificate is needed, the vendor must contact the Department of Health at (585)268-9266 no later than six (6) weeks prior to the festival date. **There's a late fee if purchased after 10 days within the festival date.**
